### Can you tell me what AEB International does?

AEB is one of Europe's leading providers of global trade and supply chain management software, consultancy, and services.

Founded in 1979 in Germany, AEB has been delivering solutions to customers for more than 35 years. The company has more than 5,000 customers in 70-plus countries worldwide and is supported by offices in the UK, Germany, Singapore, Switzerland, Sweden, the Netherlands, Czech Republic, France, and the US.

The AEB office in Leamington Spa was established in 2000 and today encompasses an expert team of 20 employees across all divisions of the business.

#### What are AEB's core products?

ASSIST4 is the comprehensive software suite for all logistics and global trade processes in international business. It combines global trade and logistics functionality in one solution because these two areas are inseparable today – from goods receipt, picking and packing, export controls, transport and customs processing, to track & trace, reporting, and billing.

The software supports global trade and logistics processes where businesses need it in order to run efficient supply chain operations in compliance with global trade rules and UK, EU, and US export control regulations – including international traffic in arms regulations (ITAR) and export administration regulations (EAR).

## How does AEB add value to UK companies?

AEB solutions support businesses in managing efficient and compliant supply chain and global trade processes – adding value from procurement to fulfilment, reducing operating costs, increasing digitisation levels, and safeguarding global trade networks.

Managing sensitive materials as well as knowledge and technology associated with these companies in the aerospace and defence (A&D) sector are subject to especially stringent export control requirements far beyond those of uncritical goods.

Companies in the A&D sector require powerful tools to ensure their supply chains are secure from end-to-end – and compliant with all UK, EU, and US regulations along the way.
